

Youth & Family Participation Rules and Entry/Waiver Form

General Rules:

- ◆ Participants do NOT need to be a 4-H or FFA member.
- ◆ Participants will be competing for prizes only. No live animals will be given away in these events.
- ◆ Participants can register for one or two of these events, as long as he/she meets the required age/weight limit.
- ◆ Waiver of liability forms must be signed by participant and parent/guardian in order to compete in Mutton Busting and the Calf Scramble.

Chicken Scrambles:

This is a contest designed to give younger children an opportunity to participate and have fun in a livestock area event.

- ◆ Participants must be 5, 6 or 7 years old (as of July 15, 2022). **No pre-registration or waiver is required.**
- ◆ There will be one scramble for each age group (3 total).
- ◆ Prizes will be awarded.

Mutton Busting:

Participants clamber aboard a wild, wooly sheep...rodeo style, and try to hold on for as long as possible.

- ◆ **Pre-registration and waiver forms are required for this event, deadline is July 14.**
- ◆ Participants must be 5, 6 or 7 years old (as of July 15, 2022) and CANNOT weigh more than 50 pounds. Participants will be weighed at check-in.
- ◆ Participants are required to supply and wear their own bicycle/motorcycle helmet. Additional protective equipment may be worn, if desired.
- ◆ Prizes will be given for top 3 longest ride times: 1st (\$20), 2nd (\$15) and 3rd (\$10) place winners in each age group.
