

The Fair of Our Collective Past

The Stephenson County Agricultural Society was formed in 1853, organizing the first county fair in 1854. Over the years, the fair evolved, with significant events such as hosting the Illinois State Fair in 1859 and later transitioning through multiple locations. The fairgrounds served various purposes, including as a Civil War training camp and later as the site for large-scale community events like horse races and agricultural competitions. By 1951, the current fairgrounds, Albertus Park, were purchased and established as the permanent home of the Stephenson County Fair. Key milestones included the construction of commercial buildings, dining facilities, and grandstands, with the fairgrounds enduring storms, epidemics, and flooding over the decades. Today, the fair continues to celebrate its rich agricultural and community heritage, marking its 70th anniversary at Albertus Park in 2022.

The 2025 Fair dates are July 22-26, 2025.







The Fair of 2025 & Beyond

In recent years, the Stephenson County Fairgrounds have made significant strides in improving both infrastructure and community involvement. Over \$100,000 has been invested in essential upgrades, including plumbing, electrical, and roof repairs, along with accessibility improvements such as a ramp at the office. The launch of new programs has bolstered agricultural education, with highlights like cow-milking demonstrations and the Everyday Ag initiative planned for 2025. The fairgrounds have embraced a digital transformation, implementing a revamped website, online camping reservations, and soon, online ticketing. Community engagement has expanded through partnerships with local organizations such as the fire and police departments, which participate in fair events to enhance visitor experiences. Looking forward, the fairgrounds plan to cultivate a park-like atmosphere with additional trees and entertainment zones while continuing to secure funding for further infrastructure enhancements to meet the evolving needs of the community.



7 Year Financial Trend





